ORDINANCE AMENDING CHAPTER XI (TRAFFIC), SECTION 11-11.1 (NO LEFT TURNS), SCHEDULE XA (NO LEFT TURNS) OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF FREEHOLD, COUNTY OF MONMOUTH, STATE OF NEW JERSEY

BE IT ORDAINED by the Township Committee of the Township of Freehold, County of Monmouth, State of New Jersey, as follows:

Chapter XI (Traffic), Section 11-11.1 (No Left Turns), Schedule XA (No Left Turns) is hereby amended by adding the following street:

Name of Street Location

Route NJ 79 and Moreau Avenue

Northbound Route NJ 79 to westbound onto Moreau Avenue

All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.

If any section, subparagraph, sentence, clause or phrase of this Ordinance shall be held to be invalid, such decision shall not invalidate the remaining portion of this Ordinance.

In accordance with the New Jersey Department of Transportation's (NJDOT) Traffic Regulation Order NT 2017-5 (NLT), this Ordinance shall take effect upon adoption and publication and the NJDOT erecting signs prohibiting the motor vehicle movement prohibited by this Ordinance.

#### **EXPLANATORY STATEMENT:**

This Ordinance shall prohibit left turns from northbound Route NJ 79 to westbound onto Moreau Avenue in accordance with NJDOT Traffic Regulation Order NT 2017-5 (NLT).

#### ORDINANCE NO. O-17-5 TOWNSHIP MEETING DATE – MARCH 20, 2017

#### CALENDAR YEAR 2017 AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

**WHEREAS,** the Local Government Cap Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 0.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS**, the Local Government Cap Law, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS,** the Township Committee of the Township of Freehold in the County of Monmouth finds it advisable and necessary to increase its Current Year 2017 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS,** the Township Committee hereby determines that a 3.5% increase in the budget for the said year, amounting to \$1,034,869.85 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years;

**NOW THEREFORE BE IT ORDAINED,** by the Township Committee of the Township of Freehold, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring that, in the Current Year 2017 budget year, the final appropriations of the Township of Freehold shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$1,034,869.85, and that the Current Year 2017 municipal budget for the Township of Freehold be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED,** that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED,** that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED,** that a certified copy of this ordinance upon adoption with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.
