- 1. **Meeting Called to Order**: Thom Ritchie called the meeting to order at 7:50

- 3. Pledge of Allegiance: Thom Ritchie led the Pledge of Allegiance
- 4. **Announcement of Open Public Meeting Act**: In accordance with the Open Public Meetings Law (c231, PL 1975), this meeting was announced by posting a notice on the bulletin board in the Municipal Building reserved for that purpose, by mailing such notice to the offices of the official newspapers and the Township and by filing such notice with the Township Clerk.

## 6. Unfinished Business:

- a. Discussed filing status of Financial Disclosure Report filing. Anyone who has yet to file should do so immediately.
- b. Discussed providing training to DPW on saw cuts, mulching and general tree maintenance. Lester to talk to Scott to see if DPW is receptive to this additional training
- c. Correspondence The monthly Shade Tree Report was reviewed and discussed. STC discussed need to do a better job of communicating to residents specifically as it relates to the removal of Heritage and Street Trees. Enforcement options were also discussed.
- d. Discussed 2017 Overlay Program effecting several streets in the Wynnefield development.
- e. Discussed need to replace several dead trees on Stillwell Corner Rd. The trees survived the first year but last years drought had a significant impact on the trees.
- f. Discussed proposed senior affordable devolvement of Highway 33 (Phrill site) and possibility of sidewalks being installed.
- g. Discussed the new CTE / Tree Removal Applicants rules including the registration requirements, insurance requirements and registration timing. Tree care companies will be required to have a Licensed Tree Expert on staff no later than April 30, 2018.
