DISCUSSION

Pet Shop Disclosure Act

Mr. Munoz reviewed the recently enacted legislation regarding Pet Shop Disclosure Act that went into effect on July 1, 2015. He offered a drafted amendment ordinance for Freehold Township to adopt. The Township Committee agreed to put it on the meeting of June 23, 2015.

Independent Fire Ladies Auxiliary Event Date Change

The Independent Fire Ladies Auxiliary was previously granted to use the field behind the fire house for a carnival in July 2015. Now they would like to change the date to September 12th with a rain date of September 26th. The Township Committee agreed.

Mayor Cook opened the meeting to the public and asked for any comments or questions.

Ronnie Liebowitz and Michael Berman from the Heritage Society explained they are interested in raising funds to move the John M. Boude house next to the Oakley House before it is destroyed by the developer. They submitted a proposed plan and projection of the fundraising. They need to raise the money by October 2015. Looking at approximately \$300,000. Mr. Valesi said Green Acres may be an issue. They explained what they would like to see the house used for, such as meeting room, program room, performances, classes and lectures for up to 60 people. After a discussion, the Township Committee agreed to support their plan and wished them good luck with the fundraising. It was decided that Mr. Munoz will review a letter that will be drafted showing the Township Committee backs the proposal.

Ms. Liebowitz said there is a certain spot they would like to put in on the Oakley property. There are no native trees there and they moved the garden.

There being no further comments or questions, Mayor Cook asked for comments from the dais.

Mrs. McMorrow stated the Municipal Alliance Golf Outing still needs more golfers for the fundraiser.

Mr. Salkin moved that the meeting adjourn to Executive Session, seconded by Mr. Preston.
