ORDINANCE NO. O-23-10 TOWNSHIP MEETING DATE – April 25, 2023

AN ORDINANCE AUTHORIZING THE SALE AND CONVEYANCE OF CERTAIN EASEMENTS TO THE COUNTY OF MONMOUTH

BE IT ORDAINED by the Mayor and Township Committee of the Township of Freehold, County of Monmouth and State of New Jersey as follows:

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:12-13.4, the Township is authorized to sell and convey property that is no longer needed for municipal purposes to the County of Monmouth for a nominal consideration; and

WHEREAS, as part of a subdivision application known as Beacon Ridge, located on Maher Road, the Township of Freehold acquired the following easements:

Sight Triangle Easement for Block 42, Lots 19, 19.04 and 19.10 by way of Deed recorded in the Monmouth County Clerk's Office on October 21, 2005 in Book 8504, Page 5060.

Slope Conservation Easement for Block 42, Lots 14, 14.01, 19 and 20 (new Lots 19.01-19.03, 19.05-19.07) by way of Deed recorded in the Monmouth County Clerk's Office on October 21, 2005 in Book 8504, Page 5075.

Shade Tree and Utility Easement for Block 42, Lots 14, 14.01, 19 and 20 by way of Deed recorded in the Monmouth County Clerk's Office on October 21, 2005 in Book 8504, Page 5098; and

WHEREAS, no improvements have been made to the property and the owner is under contract to sell the property to the County of Monmouth; and

WHEREAS, since the subdivision was not constructed and the County of Monmouth will own the property, it is no longer necessary for the Township of Freehold to hold the easement interests since they are not needed for municipal purposes by the Township of Freehold.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Freehold that it hereby authorizes the conveyance of the above referenced easements to the County of Monmouth for nominal consideration.

BE IT FURTHER ORDAINED that the Mayor and Township Clerk are hereby authorized to execute Deeds conveying the easement interests to the County of Monmouth, as well as any other documents necessary to effectuate the purpose of this Ordinance.

BE IT FURTHER ORDAINED that said Deeds shall contain a restriction that the interests conveyed therein shall be used only for public purposes of the County of Monmouth, otherwise the easement interests shall revert to the Township of Freehold.

BE IT FURTHER ORDAINED that this Ordinance shall take effect upon passage and publication according to law.

EXPLANATORY STATEMENT:

This Ordinance authorizes the sale and conveyance of certain easements to the County of Monmouth.
