

# Meeting Minutes: Freehold Township Board of Health

September 8, 2022

## Regular Meeting Minutes

### Opening

#### 1) Call to Order

The September 8, 2022 regular meeting of the Freehold Township Board of Health was called to order by Chairperson, Robin Lemesevski, at 6:42 PM. Board members present included: Michael Chudkowski, Debbie King, Dr. Steven Lemberger, and Ms. Eileen Allen. Absent: Mr. Anthony Ammiano, Dr. Fabio Apolito, Dr. Alene Opatut, and Mrs. Lisa Porth. Also present: Margaret Jahn, Health Officer and Jennifer McAuley, Recording Secretary.

The following statement was read by Robin Lemesevski: "In accordance with the Open Public Meetings Law, c.231, P.L. 1975, this meeting was announced by posting a notice on the bulletin board reserved for that purpose; by mailing such notice to the office of the official newspapers of the Township and by filing such notice with the Township Clerk."

#### 2) Minutes Approval – August 11, 2022

A motion to approve the August 11, 2022 minutes was offered by Eileen Allen, seconded by Dr. Lemberger, and carried by the Board.

#### 3) Activity Report

Ms. Jahn briefly discussed the Activity Report, mentioning the Lead investigations in Freehold Borough and the ordinance they set up prior to lead law passed by the State. The Health Department has offered to provide this service to those residents for the time being, at no cost, as part of our contract. A motion to approve the Activity Report was offered by Eileen Allen, seconded by Debbie King, and carried by the Board.

#### 4) Second Reading - Ordinance BOH 2022-01 (Amending Chapter 150 Inspection Fees)
